III. POST QUALIFICATION AND AWARDING TO THE SOLE BIDDER FOR ITB2021-004 / PR NO. 2021-12-00170

The BAC had the opening of bids pertaining to ITB2021-004/PR no. 2021-12-00170 last January 10, 2022. Chemical Research Products Industrial Sales, Inc. is the sole bidder. During the evaluation and inspection of the bidding documents, it was observed that all other requirements were rated passed except for the invalid Mayor's Permit due to E.O 2022-02 of the Municipality of Sta. Maria, Bualcan, which states the resumption of the processing of the indicated permit is on January 17, 2022. The committee agreed that the sole bidder must submit their 2022 Mayor's Permit not later than January 20, 2022.

The BAC proceeded today with the post qualification and awarding of items pertaining to ITB2021-004/PR no. 2021-12-00170. Chemical Research Products Industrial Sales, Inc. was able to submit last January 20, 2022 their 2022 Mayor's Permit. Hence, the technical component/including eligibility requirements from the sole bidder were rated passed.




