WHEREAS, the Bids and Awards Committee proceeded with the opening and comprehensive inspection of the first envelope of the sole bidder which consist the technical component/including eligibility requirements;

WHEREAS, during the evaluation and inspection of the technical requirements, ZV FISHING AND CONSTRUCTION SUPPLIES is eligible to participate to the bid and was rated passed;

WHEREAS, the committee proceeded with the evaluation and inspection of the financial requirement, however there was no BID SECURITY included in the financial requirement which was clearly stated in the instructions to bidder. In this regard, the Bids and Awards Committee rated the sole bidder as FAILURE for this requirement;

and Awards Committee declared "FAILED" bidding for the ITB2021-003 with PR No. BUB2021-09-00119 Which is the purchase of various materials for the LGU-Bayawan Water System for FY2020 and FY2021 - Sitio Guisocon, Nangke;

WHEREAS, the Bids and Awards Committee recommended "NEGOTIATED PROCUREMENT" for the items pertaining to this purchase request due to 2 failed biddings;

WHEREAS, the Bids and Awards Committee also recommended to place on hold the awarding of the fuel on even with complete canvass due to "IFAILED" bidding of the materials for this project;

WHEREAS, the Bids and Awards Committee recommended to have an updated canvass on the fuel upon awarding of the materials pertaining to this project;

WHEREAS, the Bids and Awards Committee recommended further to put remarks on the canvass on fuel that the quotation is based on actual selling price;
